The amount due to the lienor remains outstanding as of the 14th day of July, 2023.

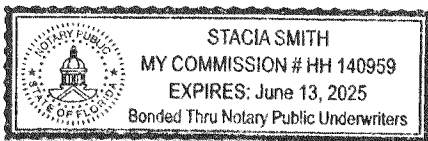
